INTRODUCTION


Consultations with the interested public in the procedure of adopting laws, other regulations and acts is not only an integral part of the modern democratic process of public policy management, but also an essential step towards strengthening the openness, responsibility and effectiveness in the work of state administration bodies. The implementation of a new concept wherein the state authorities work together with the citizens and civil society, which the Government advocates in its Programme for 2011-2015, opens the space for working together in creating, implementing and supervising the public policy that is of direct interest to the citizens.

In line with Measure 7 and Implementing Activity 7.2 of the National Strategy for the Creation of an Enabling Environment for Civil Society Development 2012-2016 and the objectives and measures of the Action Plan for the Implementation of the Initiative Partnership for Open Government in the Republic of Croatia, the Government Office for Cooperation with NGOs has been monitoring the implementation of the *Code of Practice on Consultation with the Interested Public in Procedures of Adopting Laws, Other Regulations and Acts* (The Official Gazette no. 140/2009) and is responsible for preparing and submitting the Annual Report on the Code Implementation to the Croatian Government.

In January 2014 the Government Office collected and processed the state administration bodies' and Government Offices' reports about the consultations that they had conducted in 2013, in line with the *Code of Practice on Consultation with the Interested Public in Procedures of Adopting Laws, Other Regulations and Acts*. Out of 60 state administration bodies to whom reporting requests were sent, 29 had conducted consultations in 2013 and submitted their reports on them to the Government Office.

In 2013 the state administration bodies and Government Offices conducted consultations with the interested public on the total of 348 regulations. Another 26 consultations were conducted in line with the Act on Regulatory Impact Assessment (Official Gazette no. 90/2011), which makes 374 consultations in total – an increase of 159.7% compared to 2012 when 144 consultations were conducted.

On the one hand, progress in applying standards for conducting consultations and the continuously increasing number of conducted consultations are the result of unremitting public advocacy by CSOs in different areas of activity. On the other hand, it is indisputably the result of numerous activities undertaken by the state administration bodies, which continuously invest in strengthening the civil servants and public employees' capacity for managing the consultation procedures and methods. Civil servants and public employees participated in numerous workshops conducted by the Government Office for Cooperation with NGOs in cooperation with the State School for Public Administration and regular meetings were held between the consultation coordinators from the state administration bodies and Government Offices. The Government's Public Relations Office continuously works on promoting the culture of public consultations via social networking sites. There is serious commitment to institutionalizing the practise of consultations, which was prompted by the Constitutional Court decisions and interpretations as well as other regulations pertaining to the regulatory impact assessment and the right of access to information.

STRENGTHENING THE INSTITUTIONAL AND LEGISLATIVE FRAMEWORK FOR CONDUCTING CONSULTATIONS WITH THE INTERESTED PUBLIC

2.1

IMPROVING THE LEGISLATIVE FRAMEWORK ON CONSULTATIONS WITH THE PUBLIC

An important step towards improving the legislative framework for consultations with the interested public was adopting the Act on the Right of Access to Information (Official Gazette no. 25/2013) in February 2013, by way of which the measures outlined both in the National Strategy for the Creation of an Enabling Environment for Civil Society Development 2012-2016 and in the Action Plan for the Implementation of the Initiative Partnership for Open Government in the Republic of Croatia were fulfilled.

The act stipulates, inter alia, that all public authorities competent for the drafting of laws and subordinate regulations are required to publish on their web sites the drafts of laws and other regulations about which the consultations with the interested public are conducted. As a rule, the publication is available for 30 days and includes the reasons for the adoption of a certain act as well as the objectives of consultations. Furthermore, following the conducted consultations, public authorities are required to inform the interested public, via their web sites, about accepting or rejecting comments, remarks and suggestions. They are also required to publish reports on the conducted consultations with

the interested public and submit it to the Croatian Government. It is important to mention that relevant provisions also pertain to the procedure of adopting general acts by the local and regional self-government units and legal persons vested with public authority, regulating the issues within their purview in connection with the direct exercise of citizens' rights and other issues of interest for the public good of citizens and legal persons in their area or in the area of their activity (urban design and physical planning, housing issues, public utilities and other public services, environmental protection, etc.).

New solutions in the Act on the Right of Access to Information are in compliance to the Amendments to the Croatian Government's Rules of Procedure (Official Gazette no. 121/2012) which were adopted towards the end of 2012. They confirm that public consultation and reporting on the results of consultations are an integral part of decision-making process on the level of the Croatian Government. Namely, a provision was added to the Rules of Procedure which obliges central state bodies to submit to the Government relevant reports on the conducted consultations together with the drafts of laws, other regulations and acts, provided that such consultations were conducted, in line with the special regulation, i.e. the *Code of Practice on Consultation with the Interested Public in Procedures of Adopting Laws, Other Regulations and Acts*.

Finally, it is important to mention the Constitutional Court decisions in the proceedings for the assessment of constitutionality and legality. The Constitutional Court decision interpretations contributed to the better understanding of consultation standards since it was underlined that the democratic nature of a procedure, within which a social dialogue about the issues of public benefit is taking place, constitutes in itself the grounds for assessing the act, which is the outcome of such a procedure, constitutional or unconstitutional.

2.2

STRENGTHENING THE CIVIL SERVANTS AND PUBLIC EMPLOYEES' CAPACITY FOR MANAGING THE CONSULTATION PROCEDURES AND METHODS

With a view to ensure continuing support to civil servants in the implementation of standards in consultations with the interested public, the Government Office for Cooperation with NGOs in cooperation with the State School For Public Administration offers a one day seminar entitled *Preparing and Conduct-*

ing Efficient Consultations with the Interested Public in procedures of adopting laws, Other Regulations and Acts. The seminar is aimed at civil servants on the national and local level, whose responsibilities include providing information, dealing with legal affairs and cooperating with NGOs, other civil society organisations and interest groups.

In 2013 there were 6 seminars at which 88 participants from state administration bodies, the Government Offices and local and regional self-government units took part. In order to encourage the exchange of experience and good practice among local authorities, civil society organizations and the citizens, about models of effectively conducting consultations with the public in decision-making procedures pertaining to the issues of public interest, two seminars were held on the local level for the employees of Karlovac, Virovitica-Podravina and Bjelovar-Bilogora Counties with about 50 participants.

As a continuation of the training for consultation coordinators which began in 2012 under the IPA project, the Government Office for Cooperation with NGOs has organised meetings of all consultation coordinators in order to facilitate the exchange of information and experience, provide additional training and further raise awareness on the importance of this area in the future development of services provided by the state administration bodies and Government Offices.

There were two consultation coordinators meetings in 2013. The newly appointed Information Commissioner joined one of the meetings and spoke about public authorities' obligations pursuant to the new Act on the Right of Access to Information, focusing in particular about article 11, which pertains to the publishing of documents for the purpose of consulting the interested public. The meetings of consultation coordinators were shown to be an essential element for the continuation of efforts that were initiated under the IPA Programme. They included designing and implementing a comprehensive education and training programme for consultation coordinators, organizing several trial public discussions, designing and printing a Consultation Manual and providing ongoing technical assistance to the state administration bodies and Government Offices in acquiring capacity for conducting efficient consultations between modules as well as after the closing of the Project.

Croatian experiences in the implementation of the Code of Practice on Consultations were presented to civil servants from the countries of Southeast Europe as well as international experts at an annual conference of the Regional School for Public Administration (ReSPA) which took place in Danilovgrad, Montenegro on 18 - 19 April 2013. At the conference entitled "Effective Policy Making: How to Ensure Desired Changes through Successful Implementation of the Policies" the Director of the Government Office for Cooperation with NGOs spoke during the plenary session about the Croatian Government experiences in institutionalizing the practice of consultations with the interested public in procedures of adopting laws, other regulation and acts.

Croatian experiences in implementing the standards for consultations with the public often generate a lot of interest among the participants of study programmes for civil servants who come from a number of countries under the development assistance programmes provided by the Republic of Croatia. On many occasions in 2013 the employees of the Government Office for Cooperation with NGOs exchanged experiences in this area with civil servants from Southeast Europe, Turkey, Iraq and exchange programmes with South Mediterranean countries were initiated.

2.3

PROMOTION OF CONSULTATIONS VIA SOCIAL NETWORKING AND WEB SITES

In 2013 Croatian Government's Online Communication Department systematically informed the citizens and other representatives of the interested public about the possibilities of participating in consultation procedures pertaining to new drafts of laws, other regulations and acts via social networking sites. 346 calls for participation in open public consultations were published on the Government's Twitter profile alone.

Almost all state administration bodies and Government Offices initiated special subsites devoted to consultations with the interested public which provide information and relevant documents pertaining to the ongoing as well as concluded consultations.

Within the Action Plan for the Implementation of the Initiative Partnership for Open Government, but also in line with Croatian Government's plans about establishing a central state web portal, it is envisaged that a web site devoted to consultations be set up in the forthcoming period. The web site would facilitate ongoing communication between the state administration bodies, Government Offices and the interested public about all regulations that are undergoing adoption procedure similar to the European Commission practices as well as other advance practices of other EU member states e.g. the United Kingdom. Until then, the Government Office for Cooperation with NGOs web site includes a subsite devoted to consultations with the interested public, which is currently used as a central place for sharing information about all ongoing/concluded consultations conducted by the state administration bodies and Government Offices.

3

THE ANALYSIS OF CONSULTATIONS CONDUCTED IN 2013

3.1 TOTAL NUMBER OF CONDUCTED CONSULTATIONS

According to the data submitted to the Government Office for Cooperation with NGOs, a total of 374 consultations with the interested public in procedures of adopting laws, other regulations and acts were conducted in 2013. Altogether 348 consultations were conducted about draft regulations, 26 about the regulatory impact statements and propositions pursuant to the Act on Regulatory Impact Assessment. On average, 12 consultations per state administration body and Government Office were conducted in 2013. Considering the continuing efforts in improving the consultation procedure and promoting its importance, the rise in the number of conducted consultations in 2013 was expected.

This chapter contains the analysis of the consultations about draft laws, other regulations and acts. Consultations about draft statement proposals that were conducted in line with the Act on Regulatory Impact Assessment were analysed in a separate chapter.



3.2 CONSULTATION METHODS

Due to its convenience and availability to the broadest circles of the interested public online consultation was the method most often used by the state administration bodies and Government Offices in 2013. It is important to mention that in spite of the Internet availability, proactive methods of informing the public about the ongoing consultations are gaining more and more recognition. Apart from online consultations that were conducted in connection with 344 regulations, 84 public discussions, 97 advisory meetings and several focus groups as well as various informal consultations took place.

3.3 CONSULTATION LENGTH

Out of 348 consultations, 232 lasted less than 30 days. The reason for this is frequently applied emergency procedure in adopting regulations. Considering that the Act on the Right of Access to Information, as a rule, stipulates the deadline for consultations with the interested public to be 30 days, it will be necessary to change this prevalent practice. On the occasion of announcing the legislative activity plan and the plan of consultations, which are also stipulated by the Act on the Right of Access to Information, the plan of consultations in 2014 needs to be made in advance, as an integral part of drafting laws and regulations, in order to ensure sufficient time for the interested public to respond. The longest consultation in 2013, lasting more than 130 days, was conducted by the Ministry of Justice on the Draft Act on the Amendments to the Criminal Procedure Act (Official Gazette no. 145/2013).

Graph 3 Consultation length






3.4 COMMENT SENDERS

In 2013 a total of 8299 natural and legal persons participated in consultations with the interested public who sent comment(s) on the draft laws, other regulations or acts to a competent state administration body or Government Office. 3850 comments, making by far the largest group, were sent by individuals. Other comment senders were NGOs (382), other civil society organizations like trade unions, employers' associations and religious communities (237), local and regional self-government units (88) and the academe (67).

Given that there was a higher number of a conducted consultation procedures in comparison with 2012, the number of comment senders was also higher, namely 73% higher. In comparison with 2011 the said number was 4697% higher, which shows continuously growing interest among the citizens for participating in decision-making and shaping public policy. In 2012 there were altogether 4786 comments on the draft regulations in consultation procedures whereas in 2011 only 173 comments were registered. This can undoubtedly be linked to the ongoing proactive providing of information to the citizens and the interested public about the possibilities of participation in public consultations, especially via social networking sites.

For the purpose of more precise monitoring of comment senders structure and improving the communication about open consultations with target groups, it


is recommendable that the reporting which will take place in the forthcoming period be supplemented with additional categories (e.g. companies) as well as the data about the county from which the senders come.

3.5 NUMBER OF RECEIVED COMMENTS

Graph 6 Structure of accepted, unaccepted and partially accepted comments




In total 12 738 comments on laws, other regulations and acts were received in 2013. 73% was taken in further consideration¹.

Out of 9270 comments which were taken into further consideration, 2391 were accepted, 3798 were unaccepted and 579 were partially accepted.² According to the submitted data 18% of all received comments and 23% of all comments taken into consideration were accepted. The highest number of comments in 2013, i.e. 2351, was received on the Curriculum for Health Education about which the Ministry of Science, Education and Sport conducted public consultations.

3.6 REPORTS ON CONDUCTED CONSULTATIONS

Publishing the reports on conducted consultations is essential for the integrity of the consultation procedure and gives a positive message to all consultation participants, i.e. that their efforts were acknowledged. In 2013 the state administration bodies and Government Offices drafted 149 reports about conducted consultations and 134 lists of all comments with explanations about their

acceptance/non-acceptance. For 62 consultations received comments were published in their integral form. In total 345 different types of reports were published. No feedback was given to the interested public about consultation results in 123 cases. For the majority of regulations for which no comments were received, reports were not published either. However, in the future in such cases a report on the conducted consultation needs to be published containing basic information about the consultation as well as a remark about no comments being received. On average 7 reports on conducted consultations were published per state administration body and Government Office in 2013.

In line with the Croatian Government's Rules of Procedure, when submitting draft laws, other regulations and acts to the Government procedure, central state administration bodies are obliged to also attach relevant reports on conducted consultations. The reports on conducted consultations were attached in case of 97 regulations (out of 348), i.e. for 28% of all regulations that underwent public consultations. It should be borne in mind that a certain number of regulations do not entail adoption by the Government as they are being adopted by heads of the state bodies. Furthermore, submitting additional reports on consultation results is not envisaged in cases when consultations had already been conducted in line with the regulations pertaining to regulatory impact assessment.

As a rule, acknowledgements containing confirmation of receipt are sent to all consultation participants so that comment senders know that their contributions were received and can have confidence for future participation in consultation procedures. Acknowledgments for received comments can be sent to comment senders individually or as a group after the deadline for consultation has expired. In 2013 acknowledgments were sent after 88 conducted consultations.

3.7 IMPLEMENTATION COSTS AND MAN-HOURS

Transformation of consultation practice requires strengthening the capacity of civil servants whereas the preparation and implementation of consultations and especially drafting reports about consultation results require working hours. Implementation of consultations in the state administration bodies and Government Offices is considered to be a part of regular work performed by staff members tasked with public relations, information or legal affairs. As a rule, it did not require additional costs in 2013. Although this is exactly the reason why it is difficult to determine the number of man-hours spent in preparation and implementation of consultations with the public, the data collected for this report point to more than 3000 man-hours.

4

CONSULTATIONS CONDUCTED IN LINE WITH THE ACT ON REGULATORY IMPACT ASSESSMENT³

In line with the Act, regulatory impact assessment is an integral part of decision-making about regulations based on collected evidence and relevant data, which act as guidelines for choosing the best solution in adopting regulations or initiating non-normative activities and measures. Principal expert body in drafting regulations is obliged to conduct consultations with the interested public about draft statement proposals.

In 2013 the state administration bodies and Government Offices conducted 26 consultations on draft statement proposals on regulatory impact assessment. All consultations lasted 30 or more days. Apart from online consultations, public consultations, advisory meetings and round tables also took place. In total there were 100 comment senders, i.e. 42 individuals, 29 NGOs, 12 other CSOs, one academe representative and 15 other. On the whole 393 comments were collected and 352 of those were taken for further consideration. 197 comments were accepted, 94 unaccepted and 63 partially accepted.

Reports on conducted consultations were published for 17 out of 26 consultations and in 2 consultations acknowledgments for submitted comments were sent.

CONCLUDING REMARKS AND RECOMMENDATIONS

Taking into account that a total of 374 consultations were conducted, wherein 12,738 were received and 2,391 comments were accepted this report shows progress in the implementation of consultations with the interested public in the state administration bodies and Government Offices in 2013. This is the result of significant efforts invested in systematic promotion of the *Code of Practice on Consultation with the Interested Public in Procedures of Adopting Laws, Other Regulations and Acts* by CSOs and the Croatian Government; systematic training of civil servants competent for consultation implementation and commitment to consultation practice institutionalization prompted by the Constitution Court decisions and interpretations as well as new regulations pertaining to regulatory impact assessment and right of access to information.

In 2013 the Croatian Government's Public Relations Office continued promoting all public consultations with the interested public on draft laws, regulations and other acts via social networking sites, which undoubtedly prompted more interest on the part of citizens and broader public for participation in the legislative procedure.

In order to ensure the sustainability of accomplished results and as a way of prompting additional progress in strengthening the culture of consultations in all state administration bodies, the following recommendations need to be taken into account:

- Continue to invest in further development and adjustment of training programmes on the standards of public consultations in shaping public policy for civil servants, including management level civil servants, both nationally and locally
- Improve the practice of proactively informing the interested public on published consultations
- Encourage the use of different methods of consultation in order to enable equal access to consultations to vulnerable, socially excluded groups, i.e.

adapt the consultation methods to specific needs of target groups within the interested public

- Improve the practice of drafting clear statements about the reasons as to why proposals and comments were not accepted in consultation procedures
- Improve the practice of publishing reports on the results of consultations in order to provide good quality information to organizations and individuals who devoted their time to participating in consultations and contributed to shaping better quality public policy
- Prepare guidelines for acting in line with the provisions of the Act on the Right of Access to Information, primarily regarding the contents of the standard form for drafting and publishing the plan of consultations and reporting on the results of conducted consultations
- Increase efficiency in verifying compliance with the obligation of attaching reports on conducted consultations when preparing documents for the Croatian Government sessions, as stipulated in the Rules of Procedure

In line with the objectives and measures stated in the National Strategy for the Creation of an Enabling Environment for Civil Society Development 2012-2016, as well as the objectives of the Republic of Croatia's participation in the global initiative Partnership for Open Government, the Government Office for Cooperation with NGOs, in cooperation with other state administration bodies, shall continue to implement a range of activities that should contribute to the application of the above mentioned recommendations in practice.


