THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU, Euratom) 2018/1046 of the European Parliament and of the Council of 18 July 2018 on the financial rules applicable to the general budget of the Union, amending Regulations (EU) No 1296/2013, (EU) No 1301/2013, (EU) No 1303/2013, (EU) No 1304/2013, (EU) No 1309/2013, (EU) No 1316/2013, (EU) No 223/2014, (EU) No 283/2014, and Decision No 541/2014/EU and repealing Regulation (EU, Euratom) No 966/2012¹, and in particular Article 110 thereof,

Having regard to [Regulation (EU) of the European Parliament and of the Council establishing the Citizens, Equality, Rights and Values Programme and repealing Regulation (EU) No 1381/2013 and Regulation (EU) No 390/2014]², and in particular Article 13 thereof,

Whereas:

- (1) In order to ensure the implementation of the Citizens, Equality, Rights and Values Programme, it is necessary to adopt a multiannual financing decision, which constitutes the multiannual work programme, for 2021-2022. Article 110 of Regulation (EU, Euratom) 2018/1046 ('the Financial Regulation') establishes detailed rules on financing decisions.
- (2) The multiannual financing decision should be adopted before the adoption of the basic act in order to guarantee a timely implementation of the programme, whereby (potential) beneficiaries will receive support for actions within its scope.
- (3) It is appropriate to authorise the award of grants without a call for proposals and to provide for the conditions for awarding those grants.
- (4) It is necessary to allow for the payment of interest due for late payment on the basis of Article 116(5) of the Financial Regulation.
- (5) In order to allow for flexibility in the implementation of the work programme, it is appropriate to allow changes which should not be considered substantial for the purposes of Article 110(5) of the Financial Regulation.
- (6) In accordance with Articles 7(10) and 24 of [Regulation (EU) of the European Parliament and of the Council establishing the Citizens, Equality, Rights and Values Programme] and point (a) of the second subparagraph of Article 193(2) of the Financial Regulation and by derogation from Article 193(4) of the Financial Regulation, where duly justified, activities and costs regarding grants financed under this Decision may be eligible from the beginning of the 2021 financial year, even if implemented and incurred before the grant application was submitted.

- (7) The measures provided for in this Decision are in accordance with the opinion of the Committees established by Article 10 of Regulation (EU) No 1381/2013 of the European Parliament and of the Council and Article 9 of Regulation (EU, Euratom) No 390/2014 of the Council.
- (8) The work programme was submitted to those committees for informal consultation.

HAS DECIDED AS FOLLOWS:

Article 1
The work programme

The multiannual financing decision, constituting the multiannual work programme for the implementation of the Citizens, Equality, Rights and Values Programme for the years 2021-2022, as set out in the Annex, is adopted.

Article 2
Union contribution

The maximum Union contribution for the implementation of the programme for the years 2021-2022 is set at EUR 91 169 287³ for 2021 and EUR 200 901 193 for 2022, and shall be financed from the appropriations entered in the following lines of the general budget of the Union:

- (a) budget line 07 06 01: EUR 27 324 300³ for 2021 and EUR 39 860 945 for 2022;
- (b) budget line 07 06 02: EUR 13 977 154³ for 2021 and EUR 39 671 295 for 2022;
- (c) budget line 07 06 03: EUR 19 189 700³ for 2021 and EUR 29 581 401 for 2022;
- (d) budget line 07 06 04: EUR 30 678 133³ for 2021 and EUR 91 787 552 for 2022.

The appropriations provided for in the first paragraph may also cover interest due for late payment.

The implementation of this Decision is subject to:

- (a) the final adoption of [Regulation (EU) European Parliament and of the Council establishing the Citizens, Equality, Rights and Values Programme] by the legislative authority and its entry into force without significant modifications;
- (b) a positive opinion by the programme committee established by [Regulation (EU) European Parliament and of the Council establishing the Citizens, Equality, Rights and Values Programme];
- (c) the availability of the appropriations provided for in the draft general budget of the Union for 2022, following the adoption of that budget by the budget authority or as provided for in the system of provisional twelfths.
- (d) the approval of transfers between lines for 2021 by the budgetary authority.

Article 3
Flexibility clause

Cumulated changes to the allocations to specific actions not exceeding 20% of the maximum Union contribution set in the first paragraph of Article 2 of this Decision shall not be considered to be substantial for the purposes of Article 110(5) of the Financial Regulation, where those changes do not significantly affect the nature of the actions and the objective of the work programme. The increase of the maximum Union contribution set in the first paragraph of Article 2 of this Decision shall not exceed 20%.

The authorising officer responsible may apply the changes referred to in the first paragraph. Those changes shall be applied in accordance with the principles of sound financial management and proportionality.

Article 4
Grants

Grants may be awarded without a call for proposals to the body selected in accordance with points 3.14 and 3.15 of the Annex.

1. INTRODUCTION

Citizens,

“I want Europe to strive for more in nurturing, protecting and strengthening our democracy. I want Europeans to build the future of our Union. They should play a leading and active part in setting our priorities and our level of ambition.”

Equality,

“A prosperous and social Europe depends on us all. We need equality for all and equality in all of its senses.”

Political Guidelines

Article 2 of the Treaty on the European Union states that ‘the Union is founded on the values of respect for human dignity, freedom democracy, equality, the rule of law and the respect for human rights, including the rights of persons belonging to minorities. These values are common to the Member States in a society where pluralism, non-discrimination, tolerance, justice, solidarity and equality between women and men prevail’.

These rights and values must continue to be actively developed, protected, promoted, enforced and shared among people in the EU and be at the heart of the EU project; deterioration in their enjoyment and protection in any one Member State will be harmful to the EU as a whole.

The Citizens, Equality, Rights and Values programme¹ provides funding for citizens’ engagement, promoting equality for all and implementing EU rights and values. As highlighted by President Ursula von der Leyen in her political guidelines, these will be key policy priorities of the Commission's work in upcoming years.

At a time when European societies are confronted with extremism, radicalism and divisions and a shrinking space for independent civil society, it is more important than ever to promote, strengthen and defend justice, rights and EU values: human rights, respect for human dignity, freedom, democracy, equality and non-discrimination, and the rule of law. This will have profound and direct implications for political, social, cultural and economic life in the EU.

The Citizens, Equality, Rights and Values programme ('the programme') brings together the former Rights, Equality and Citizenship² and Europe for Citizens programmes³.

Its general objective is to protect and promote the rights and values enshrined in the Treaties, the Charter of Fundamental Rights of the European Union and in the applicable international human rights conventions. The programme does this in particular by supporting civil society organisations and other stakeholders active at local, regional, national and transnational level, and by encouraging civic and democratic participation, in order to sustain and further develop open, rights-based, democratic, equal and inclusive societies based on the rule of law. It pays particular attention to encouraging the participation of regional and local civil society organisations.

In particular, the programme supports the following specific objectives, which correspond to its strands of activity:

- to protect and promote Union values (Union values strand);
- to promote rights, non-discrimination and equality, including gender equality, and to advance gender mainstreaming and the mainstreaming of non-discrimination (equality, rights and gender equality strand);
- to promote citizens' engagement and participation in the democratic life of the Union and exchanges between citizens of different Member States, and to raise awareness of their common European history (citizens' engagement and participation strand);
- to prevent and combat gender-based violence and violence against children (Daphne strand).

In accordance with the Financial Regulation, the programme provides for the possibility to set up multiannual work programmes and financing decisions. Multiannual work programmes make it possible to define the political objectives of a programme with a longer-term perspective and to give more transparency to (potential) beneficiaries as regards the programme's priorities. Potential beneficiaries thus have more time to develop their actions and to build partnerships. A two-year approach also improves stability, while still allowing for the necessary flexibility, periodic changes and the introduction of new ideas, taking into account emerging policy priorities.

The work programme for 2021-2022 presents how funding will support the implementation of the Commission's many initiatives on the ground, translating policies into action. It provides financial assistance for training activities, workshops, conferences, mutual learning and cooperation, capacity building, town twinning, media campaigns, awareness raising and dissemination activities. In this context, the work programme aims to finance civil society organisations as well as public authorities, European-level networks and think tanks.

1.1. Union values

Full respect and promotion of fundamental rights, the rule of law and democracy are key to building people's trust in the EU and ensuring mutual trust among Member States. The programme will contribute to building a more democratic EU, respect for the rule of law,

fundamental rights and democratic dialogue, transparency and good governance, including in cases of shrinking space for civil society.

Funding under the programme will support entities that contribute to making the EU's common values, rights and equality and rich diversity alive and vibrant. The ultimate objective is to nurture and sustain a rights-based, equal, open, pluralist, inclusive and democratic society. This includes a strong and empowered civil society that fosters people's democratic, civic and social participation and inclusiveness, and further develops the diversity of European society, based on our common values, history and memory. Actions will contribute to implementing EU priorities, in particular in the area of fundamental rights, the rule of law and democracy, as highlighted in the Rule of Law report⁴, the European democracy action plan⁵ and the strategy to strengthen the application of the Charter of Fundamental Rights in the EU⁶.

1.2. Equality, rights and gender equality

The work programme aims to support a comprehensive and intersectional approach and specific actions to promote equality, tackle discrimination and improve responses to racism and xenophobia in the form of hate speech and hate crime, both on- and offline. It also aims to address the vulnerabilities of specific groups and communities particularly affected by discrimination, such as Roma, Jews, Muslims, migrants, people of colour and people of African descent. It will support the implementation of the EU anti-racism action plan for 2020-2025⁷, the LGBTIQ Equality Strategy 2020-2025⁸, the EU Roma strategic framework on equality, inclusion and participation⁹, and the forthcoming EU Strategy on combating antisemitism.

Funding priorities also include promoting diversity management, monitoring and enforcing non-discrimination and hate crime legislation, strengthening stakeholder dialogue on Roma equality and inclusion at European and national levels, and advancing the work of the Commission's coordinators on combating racism, antisemitism and anti-Muslim hatred. Funding will be used to complement the activities of Member States and equality bodies on promoting and protecting rights and implementing the EU anti-discrimination legislation, including the Commission Recommendation on standards for equality bodies¹⁰, and on improving the collection of equality data.

The work programme will also continue to address the worrying phenomenon of online hate speech and improve Member State capacity to: (i) develop national and local strategies and action plans against racism, (ii) develop a common methodology for collecting data on hate crimes and hate speech, (iii) promote a comprehensive training strategy for law enforcement to effectively prosecute instances of hate crime and speech, and (iv) provide support services for victims of hate crime.

The Commission promotes gender equality based on the Gender Equality Strategy for 2020-2025¹¹, for a Europe where women and men, girls and boys, in all their diversity¹² are equal.

In this context, the work programme will support awareness raising and other policy activities for the promotion of equal participation/representation of women and men in political and economic decision making. It will also continue to tackle gender stereotypes, including with a focus on youth, as well as in advertising and the media.

Gender equality is one of the key principles of the European Pillar of Social Rights¹³, which is the EU's compass to build a fairer Europe and to promote better living and working conditions for all. In particular, its Principle 2 calls for equality of treatment and opportunities between women and men in the labour market, terms and conditions of employment, career progression and the right to equal pay. The European Pillar of Social Rights Action Plan¹⁴ will play a key role in this context.

Funding for protecting children's rights will respond to the current situation and address children's needs arising from the impact of COVID-19, as well as generally promoting mechanisms to safeguard children's rights in time of crisis. The activities funded under this work programme will further support the implementation of recommendations made under the EU Strategy on the rights of the child¹⁵ at the EU, national and local level.

To achieve further progress in ensuring the full participation of people with disabilities and enjoyment of their rights on equal basis with others, and in line with the UN Convention on the Rights of Persons with Disabilities (UNCRPD)¹⁶, funding is being allocated to actions aiming to promote and protect the rights of people with disabilities. Such actions will support the Strategy for the rights of persons with disabilities 2021-2030¹⁷ that intends to tackle the diverse challenges and barriers that people with disabilities face. This work programme aims to support members of civil society active in the disability field, and to improve knowledge and share experiences on achievements at European and national level and on meeting commitments deriving from the UNCRPD.

Further efforts are needed to increase the EU citizens' awareness of rights conferred by EU citizenship, including the right to move and reside freely on the territory of the Member States (including understanding the conditions that apply to this)¹⁸. The work programme includes activities aiming to strengthen and nurture democracy in the EU, including through building knowledge and raising awareness on the rights of EU citizenship and the associated EU common values, and by fostering the successful inclusion and political participation of EU citizens, including mobile EU citizens, in civic and political life.

The General Data Protection Regulation¹⁹, which entered into application in May 2018, strengthened citizens' rights and cut costs and red tape for European business. In order to support the implementation of this legislation at national level, funding will continue to be provided to national Data Protection Authorities for reaching out to stakeholders. The work programme will also continue to support awareness-raising campaigns, complementing those

carried out at national level, studies and reports supporting the implementation of the data protection framework.

1.3. Citizens' engagement and participation

It is important to give people the opportunity to take part in the debate on Europe and to play a strong role in developing the EU. Through the 'Citizens' engagement and participation' strand, the work programme will help people make their voices heard and increase inclusion and democratic participation, in line with the Commission's political priorities, including those specified in the EU Citizenship Report 2020²⁰ and the European democracy action plan²¹. It will also contribute to building a more democratic EU by supporting the activities of civil society organisations and other relevant entities active in promoting rights and values at local, regional and national level. This will be part of the common effort to uphold rights and values including by reinforcing a rule of law culture in the EU.

Activities will also promote cultural diversity and the knowledge of shared history. They will encourage EU citizens' responsible, democratic civic participation in shaping the future of the EU and will foster their feeling of belonging in the EU.

In the area of European remembrance, the Commission will support projects that commemorate defining events in modern European history, including the causes and consequences of authoritarian and totalitarian regimes. It will also support projects on Holocaust remembrance, as well as research and education that is in line with the upcoming EU strategy on combating antisemitism and the EU Roma strategic framework on equality, inclusion and participation. Activities will aim to raise awareness among Europeans of their common history, culture, cultural heritage and values, improving their understanding of the EU, its origins, purpose, diversity and achievements and of the importance of mutual understanding and tolerance.

In the area of citizen participation, the Commission will promote civic and democratic participation, giving EU citizens and representative associations the possibility to take part in and contribute to the EU's democratic and civic life. Activities will look in particular at the European Parliament elections of 2024, European Citizens' Initiative and innovative approaches and tools to help citizens make their voices heard and publicly exchange views on all areas of EU action, including via digital tools (e-democracy).

In the area of town twinning and networks of towns, the Commission will promote exchanges between people of different countries, to reinforce mutual understanding and tolerance and give them the opportunity to broaden their perspective and develop a sense of European belonging and identity. While maintaining a bottom-up approach, the programme will also provide, in particular to networks of towns, an opportunity to focus on EU priorities, to for example improve local knowledge of the EU Charter on Fundamental Rights, contribute to increasing the turnout and inclusive candidacy at the European Parliament elections, and increase awareness of discrimination and racism and its consequences.

1.4. Daphne: preventing and combatting gender-based violence and violence against children

The work programme will finance activities on preventing and combating gender-based violence, including online violence. Violence against children²² will also be addressed, to contribute to the strengthening of child protection systems. The specific objectives of the Daphne strand are the following:

- preventing and combating at all levels all forms of gender-based violence against women and girls and domestic violence, including by promoting the standards laid down in the Council of Europe Convention on preventing and combating violence against women and domestic violence;
- preventing and combating all forms of violence against children, young people and other groups at risk, such as LGBTQI persons and persons with disabilities;
- supporting and protecting all direct and indirect victims of the forms of violence referred to in points (1) and (2), such as the victims of domestic violence perpetrated within the family or within intimate relationships, including children orphaned as a result of domestic crimes, and supporting and ensuring the same level of protection throughout the Union for victims of gender-based violence.

2. BUDGET OVERVIEW FOR 2021-2022

Based on the objectives given in [Regulation (EU) of the European Parliament and of the Council establishing the Citizens, Equality, Rights and Values programme], this work programme presents the actions to be financed and the budget breakdown for 2021-2022 as indicated in the table below.

Funds committed in the work programme are deployed via grants and procurement and by awarding prizes, in compliance with the rules set out in the Financial Regulation.

Procurement is the acquisition of a service by the Commission from an economic operator²³, selected following a 'call for tenders' procedure.

Grants are financial contributions by way of donation by the Commission in order to finance one of the following: (i) an action intended to help achieve an EU policy objective (action grants), or; (ii) the functioning of a body which has an objective forming part of, and supporting, an EU policy (operating grants)²⁴. The award of a grant follows, in general, a call for proposals' procedure.

Prizes are financial contributions given by the Commission as a reward following a contest. They promote the achievement of policy objectives of the Union²⁵.

The implementation of actions will be directly managed by the Commission's Directorate-General for Justice and Consumers (DG JUST), unless specified otherwise. One particular exception is the implementation of actions under the specific objective to protect and promote the rights of persons with disabilities, which will be managed by the Directorate-General for Employment, Social Affairs and Inclusion (DG EMPL).

The Commission delegates powers²⁶ to implement actions in the Citizens' engagement and participation strand and the Union values strand to the European and Culture, Executive Agency (EACEA)²⁷.

All activities implemented under this work programme must respect and be implemented in line with the rights and principles enshrined in the Charter of Fundamental Rights of the European Union. They must promote and support gender mainstreaming, the mainstreaming of children's rights and the mainstreaming of non-discrimination. The budget allocation per specific objective is presented in the table below.

their participation in the programme, this will be announced in the relevant call for proposals²⁹.

The programme will finance actions with European added value³⁰. This added value, including that of small-scale and national actions, will be assessed in the light of criteria such as: (i) contribution to the consistent implementation of EU law, values and policies, and to increasing public awareness of related rights and benefits; (ii) contribution to the reinforcement of a culture based on the rule of law, democracy and fundamental rights; (iii) potential to develop mutual trust among Member States and to improve cooperation across borders; (iv) contribution to the development and dissemination of good practices, and; (v) potential to contribute to the creation of minimum standards and solutions addressing challenges across borders or EU-wide.

Activities implemented under this work programme will ensure consistency, complementarity and synergies with funding programmes supporting policy areas with close links to the Citizens, Equality, Rights and Values programme. These include: the Justice programme, the Asylum, Migration and Integration Fund, the European Regional Development Fund the Creative Europe programme and Erasmus+, which realise the potential of cultural crossovers in the fields of culture, media, arts, education and creativity; the European Social Fund+ in the fields of employment and the fight against social exclusion, and the Horizon Europe programme in the field of research on democracy, governance, EU values and social and economic transformations.

In the area of external action, complementary programmes include the Instrument for Pre-accession Assistance and the Neighbourhood, Development and International Cooperation Instrument. Coordination within the EU's legal and policy framework on trafficking in human beings under the mandate of the EU Anti-trafficking Coordinator will also be ensured.

2.1. Essential eligibility, selection and award criteria for action grants

The essential **eligibility** criteria for action grants are specified in the calls for proposals.

Grant applicants and partners must meet the following **selection criteria**:

- (a) applicants and partners must have stable and sufficient sources of funding to maintain their activity throughout the duration of the grant and to participate in its funding ('financial capacity');
- (b) applicants and partners must have sufficient operational and professional capacities to implement the activities for which co-funding is requested ('operational capacity').

Organisations participating in several projects must have sufficient financial and operational capacity to implement multiple projects.

The verification of financial capacity does not apply to international organisations and public bodies³¹.

Proposals will be assessed based on the following **award criteria**:

- (a) relevance to the priorities of the call for proposals;

3.1. Call for proposals on protecting and promoting Union values

BUDGET LINE

OBJECTIVES

Protecting, promoting and raising awareness of rights by providing financial support to civil society organisations which are active at local, regional, national and transnational level in promoting and cultivating those rights, thereby also strengthening the protection and promotion of Union values and respect for the rule of law and contributing to the construction of a more democratic Union, democratic dialogue, transparency and good governance.

Policy initiatives supported: European democracy action plan, EU Citizenship Report 2020, Rule of law report, Strategy to strengthen the application of the Charter of Fundamental Rights in the EU, Gender Equality Strategy, EU anti-racism action plan, EU Roma strategic framework on equality, inclusion and participation, LGBTIQ Equality Strategy, Strategy for the rights of persons with disabilities 2021-2030, EU Strategy on the rights of the child, EU strategy on combating antisemitism.

TYPE OF APPLICANTS TARGETED

Civil Society Organisations (CSOs) active in promoting and protecting the rule of law, fundamental rights and democracy.

POLICY PRIORITIES

2022

The EU's aim is to promote peace and the well-being of its people. The EU is founded on the values of respect for human dignity, freedom, democracy, equality, including gender equality, the rule of law and respect for human rights, including the rights of people belonging to minorities.

Civil society has a key role to play in upholding the common values on which the EU is founded: the rule of law, fundamental rights and democracy. In particular, civil society organisations act as watchdogs to monitor the upholding of democratic values in the EU and contribute to checks and balances, together with independent courts and media.

The EU aims to create a supportive environment for civil society organisations that are engaged in the promotion and protection of EU values across the Member States, in full compliance with the values and rights enshrined in the Treaties and in the EU Charter of Fundamental Rights.

Many civil society organisations face growing difficulties in securing the necessary funding to develop and perform their activities independently and effectively³³. Moreover, the COVID-19 crisis has worsened these difficulties as it impacted some traditional means of revenues.

Recent developments in some Member States have shown that respect for EU values cannot be taken for granted. For some Member States, infringement procedures under Article 258 of the Treaty on the Functioning of the European Union³⁴ have been launched. The procedure under Article 7(1) of the Treaty on the European Union³⁵ has also been triggered for some Member States in order to protect the EU's fundamental values. Moreover, for some Member States, the Council has recommended, in the context of the European semester, to strengthen judicial independence or the anti-corruption framework, or to improve access to public information and ensure effective public consultations.

The Commission also monitors respect of the rule of law, including the framework for civil society, in its annual rule of law report and the respect of fundamental rights in its annual report on application of the Charter. Dedicated measures to strengthen the resilience of European democracies are included in the European democracy action plan, including measures on protecting journalists and civil society from lawsuits against public participation (SLAPP).

Not addressing persisting gaps and new challenges could jeopardise the rule of law, fundamental rights and democracy.

The aim of the call is to encourage and facilitate active and inclusive participation in building a more democratic EU, as well as raising awareness on rights and values through support to civil society organisations. This would also strengthen the protection and promotion of Union values and the respect of the rule of law, and contribute to democratic dialogue, transparency and good governance, including in cases of shrinking space for civil society.

Financial support will be provided to civil society organisations active at local, regional, national and transnational level in promoting and cultivating these values, and active in the fields covered by the programme.

EU funding should contribute to support, empower and build the capacity of independent civil society organisations active in the promotion of values and rights, whose activities help the strategic enforcement of rights under EU law and the EU Charter of Fundamental Rights, including through advocacy and watchdog activities, as well as to promote, safeguard and raise awareness of the Union's values at local, regional, national and transnational level.

The call will finance a limited number of transnational, national or regional actors/intermediaries which will build the capacities of and re-grant (i.e. further disburse the grant) to civil society organisations active at local, regional, national level.

DESCRIPTION OF ACTIVITIES

Activities must integrate the principles of the rule of law, fundamental rights and democracy. The following list of activities is not exhaustive and other relevant and innovative activities may be considered:

- Support and capacity building for CSOs through funding (i.e. financial support to third parties), including the publication of calls for proposals, the definition of selection and award criteria, the evaluation of applications and the monitoring of

implementation;

- awareness-raising for CSOs on the rule of law culture in the EU and its Member States;

POLICY PRIORITIES

2022

1. Capacity-building and awareness raising on the EU Charter of Fundamental Rights

To contribute to the effective and coherent application of the EU Charter of Fundamental Rights (the Charter), in line with the Strategy to strengthen the application of the Charter in the EU and to foster a culture of fundamental rights in the Member States.

2. Activities on strategic litigation

To strengthen the knowledge and ability of practitioners, legal professionals, civil society organisations and independent human rights bodies to effectively engage in litigation practices at national and European level, and to improve access to justice and enforcement of rights under EU law, including the Charter, through training, knowledge sharing and exchange of good practices.

DESCRIPTION OF ACTIVITIES

The following activities can be covered:

- capacity building and awareness raising activities aiming to increase the knowledge and the use of the EU Charter;
- facilitating cooperation between key actors in enforcing the Charter, such as civil society organisations, National Human Rights Institutions, Equality bodies, Ombuds Institutions and Member State authorities (at national, regional and local level);
- training and train-the-trainer activities for professionals (such as experts, lawyers and

legal advisers, communicators, policy and advocacy advisers), including through operational guidance and learning tools;

- mutual learning, exchange of good practices, development of working and learning methods, including mentoring programmes that may be transferable to other countries;
- analytical activities, such as data collection and research, and the creation of tools or data bases (e.g. thematic databases of jurisprudence);
- communication activities, including dissemination of information and awareness raising about rights and redress mechanisms, relevant to the priorities of the call.

EXPECTED RESULTS

- increased awareness and better use of the Charter by CSOs, NHRIs, equality bodies, Ombuds Institutions and Member State authorities;
- improved knowledge about available redress mechanisms and how to make the best use of them for the benefit of rights holders;
- improved cooperation between CSOs, NHRIs, Equality bodies, Ombuds Institutions and Member State authorities on Charter-related issues;
- increased ability of CSOs, NHRIs, equality bodies and Ombuds Institutions to develop a litigation strategy, and communicate and advocate around it, and to bring strategic litigation cases before national courts and the European Court of Justice.

3.3. Call for proposals to promote equality and to fight against racism, xenophobia and discrimination

BUDGET LINE

Budget line 07 06 01: Promote equality and rights

OBJECTIVES

Promoting equality and preventing and combating inequalities and discrimination on grounds of sex, racial or ethnic origin, religion or belief, disability, age or sexual orientation and respecting the principle of non-discrimination on the grounds provided for in Article 21 of the Charter.

Supporting, advancing and implementing comprehensive policies to combat racism, xenophobia and all forms of intolerance, including homophobia, biphobia, transphobia and interphobia and intolerance on the basis of gender identity, both online and offline.

Policy initiatives supported: EU anti-racism action plan, LGBTIQ Equality Strategy, EU Strategy on combating antisemitism, EU Roma strategic framework on equality, inclusion and participation, EU Strategy on victims' rights.

TYPE OF APPLICANTS TARGETED

Member States' public authorities, at all levels, including equality bodies and civil society organisations, such as community-based organisations.

POLICY PRIORITIES

2021 and again in 2022

The objective is to support a comprehensive and intersectional approach and specific actions to prevent and fight against intolerance, racism, xenophobia, and discrimination, in particular on grounds of racial or ethnic origin, colour, religion, sexual orientation, gender identity, including when this manifests in the form of antigypsism, antisemitism, anti-Muslim hatred, Afrophobia and LGBTIQ phobia, offline and online³⁶. In this context, the call for proposals can cover actions addressing the impact of the COVID-19 pandemic affecting these groups in terms of intolerance, racism, xenophobia, discrimination and hate. With this aim, the following priorities will be financed:

1. Fighting against intolerance, racism, xenophobia, discrimination, hate speech and hate crimes

Having reference to the policy framework set out in the Commission staff working document (2019)110 on 'Countering racism and xenophobia in the EU. Fostering a society where pluralism, tolerance and non-discrimination prevail', the EU anti-racism action plan for 2020-2025, the EU Roma strategic framework for equality, inclusion and participation and the forthcoming EU Strategy on combating antisemitism, this priority entails activities providing holistic responses to intolerance, discrimination in particular

on grounds of racial or ethnic origin, colour and religion, as well as racism, xenophobia in the form of hate crimes, hate speech, including their manifestations on the ground and from an intersectional perspective.

The call will support projects aiming to respond to the vulnerabilities of specific groups and communities particularly affected by intolerance, racism, xenophobia and discrimination, such as Roma, Jews, Muslims, migrants, people of colour and people of African descent.

In this context, the call will finance projects contributing to the implementation of the EU Roma strategic framework on equality, inclusion and participation, namely addressing antigypsyism, including hate speech and hate crime and discrimination of Roma in (access to) inclusive education, employment, health and housing, fostering rights awareness and reporting of discrimination, promoting societal support for Roma inclusion, and promoting political, social and cultural participation of Roma people. The priority will also cover the diversity of Roma, with a specific focus on Roma women, youth, children and EU mobile Roma.

The call will also support actions to prevent and combat all forms of antisemitism by raising awareness of antisemitism, supporting victims of antisemitism, improving the collection of antisemitic incident data, encouraging reporting of such incidents, educating the public about the diversity of Jewish life, supporting intercultural and interreligious dialogue, and strengthening the resilience of Jewish communities.

Moreover, the call will support the fight against anti-Muslim racism and discrimination, to raise awareness of public authorities, foster reporting by victims, address negative stereotypes, intolerance and hate speech against Muslims, and tackle the intersectional discrimination affecting Muslim women and communities belonging to socially and economically disadvantaged sectors of society.

Furthermore, the call will include activities to prevent and fight xenophobia and anti-migrant intolerance as well as to respond to the structural forms of racism faced by people of colour and people of African descent, including by building trust between communities and national authorities and increased reporting.

Finally, the priority will include initiatives aiming to empower and support the role of civil society organisations, activists and community leaders and improve reporting, rights-awareness, protection and interest representation of victims, thus contributing to the effective implementation of the Racial Equality Directive (Council Directive 2000/43/EC) and the Framework Decision on combating racism and xenophobia (Council Framework Decision 2008/913/JHA).

Indicative budget: EUR 5 400 000 in 2021 and EUR 7 740 000 in 2022.

2. Promoting diversity management and inclusion at the workplace, both in the public and private sector

This entails increasing the number of Diversity Charters in EU Member States, their number of signatories and the specific actions that promote diversity and inclusion at the workplace, with regard in particular to the six grounds for discrimination listed in Article 19 of the Treaty on the Functioning of the European Union or their intersectionality.

Indicative budget: EUR 500 000 in 2021 and EUR 500 000 in 2022.

3. Fighting discrimination against LGBTIQ people and promoting LGBTIQ equality through the implementation of the LGBTIQ Equality Strategy

This entails actions to implement the key policy objectives set out in the LGBTIQ Equality Strategy 2020-2025. It includes in particular initiatives that aim to address intersectional discrimination and inequality experienced on grounds of sexual orientation, gender identity, gender expression and sex characteristics in the area of employment, education and health. The focus is on the most vulnerable parts of the LGBTIQ community, such as transgender and intersex people, and includes the training of relevant professionals. This priority also encompasses actions that seek to tackle gender and sexuality stereotypes in and through education, provide support to rainbow families and raise awareness of the challenges they face, and prevent and combat LGBTIQ-phobic hate crimes and hate speech.

Indicative budget: EUR 1 000 000 in 2021 and EUR 1 000 000 in 2022.

4. Preventing, reporting and countering hate speech online

This entails actions to: (i) foster systematic reporting and recording of hate speech cases and incidents online, (ii) strengthen cooperation between public authorities, civil society organisations and IT companies, in particular in the area of prevention, education and awareness raising about tolerance and against hatred online (targeting in particular young people), and (iii) increase public awareness of online hate speech, including through the promotion of positive narratives and online campaigns.

Indicative budget: EUR 1 500 000 in 2021 and EUR 1 500 000 in 2022.

5. Restricted to public authorities to improve their responses to (intersectional) discrimination, racism and xenophobia, in particular, based on racial or ethnic origin, religion, or colour as well on sexual orientation, gender identity, gender expression or sex characteristics

This priority targets public authorities at national, regional and local level and helps them improve implementation on the ground of the Racial Equality Directive, the Framework Decision on combating racism and xenophobia and Commission Recommendation C(2018) 3850 on standards for equality bodies. Activities could include: issuing action plans or strategies against racism; training of law enforcement officials and/or authorities at national, regional or local level; improving recording and data collection practices in Member States, in particular building on the work of the European Union Agency for Fundamental Rights work on equality data and the recording and collection of data on hate crimes; improving support for victims of (intersectional) discrimination, in particular on the basis of racial or ethnic origin, religion or colour, sexual orientation, gender identity, gender expression or sex characteristics, as well as racist or xenophobic hate crime and hate speech at national, regional or local level; addressing underreporting; building trust between communities and public authorities.

Indicative budget: EUR 1 500 000 in 2021 and EUR 1 500 000 in 2022.

DESCRIPTION OF ACTIVITIES

Activities shall include:

1. coalition and capacity building, training of professionals and victims of (intersectional)

discrimination, hate speech and hate crimes;

- mutual learning, exchange of good practices, cooperation, including identifying best practices which may be transferable to other participating countries;
2. dissemination and awareness-raising, including social media or press campaigns;
 3. studies and analytical activities;
 4. promotion of digital skills and critical thinking;
 5. data recording, data collection, surveys, monitoring and reporting of incidents of discrimination, hate speech and hate crime, including analysis of trends, triggers and ecosystem of online hatred;
 6. victim empowerment and support;
- designing and implementing strategies or plans of action;
7. capacity building and training activities for national, regional and local authorities.

N.B.: activities that support specific political parties will not be funded, regardless of their grounds for applying or objectives.

EXPECTED RESULTS

1. Fighting against any form of intolerance, racism, xenophobia, discrimination, hate speech and hate crimes:

- increased knowledge of EU and national non-discrimination legislation as well as administrative practices in the non-discrimination field, including practices and policies covering multiple discrimination;
- increased knowledge of EU and national hate crime and hate speech legislation as well as national actions to enhance the capacity of law enforcement aimed at enhancing and effective detection of bias indicators, including in multi-stakeholder cooperation;
- reduced episodes of discrimination, in particular based on racial or ethnic origin, religion, or colour (possibly intersecting with other grounds of discrimination), of racism, xenophobia and other forms of intolerance and their manifestations on the ground, in particular hate crime and hate speech;
- increased rights-awareness, protection and interest representation of victims of hate crime and discrimination based on racial or ethnic origin, religion or colour (possibly intersecting with other grounds for discrimination);
- more effective implementation and enforcement of the legislation on non-discrimination, hate speech and hate crimes, as well as improved independent monitoring and reporting;
- increased knowledge and awareness of biases and stereotypes, in particular among school staff and journalists;
- empowered and increased protection for groups, communities and individuals affected by manifestations of intolerance, including hate crime and hate speech, with a particular focus on antigypsyism, antisemitism, anti-Muslim hatred, homophobia, transphobia and Afrophobia.

2. Promoting diversity management and inclusion:

- increased number of Diversity Charters and of companies affiliated to a charter;
- increased diversity in business, supported by strengthened links between the academic/research community and the business world;
- more inclusive workplaces and societies;
- increased Europe-wide tools measuring diversity and inclusion at the workplace.

3. Fighting discrimination against LGBTIQ people and promoting LGBTIQ equality through the implementation of the LGBTIQ equality strategy:

- improved knowledge and awareness of the intersectional discrimination and inequality experienced by LGBTIQ people, in particular by transgender and intersex people, in employment, education and health, as well as of best practices and solutions on how to tackle this;
- increased awareness and improvement of skills of relevant professionals, including health, media and business professionals and school staff, to counter stereotyping, stigmatisation, pathologisation, discrimination, harassment and bullying affecting LGBTIQ people;
- increased support for LGBTIQ people and their families, including through information campaigns, support groups, counselling and other means, and improved knowledge and awareness of the challenges they face;
- more actions that prevent and combat LGBTIQ-phobic hate crimes and hate speech;
- better guidance for national authorities and schools on how to prevent and combat school violence and bullying against LGBTIQ students, include positive representations of LGBTIQ diversity in education, tackle gender and sexuality stereotypes in education and accommodate the needs of transgender, intersex and non-binary children in educational settings.

4. Preventing, reporting and countering hate speech online:

- increased knowledge on the phenomenon of hate speech online, gathered in particular through systematic reporting and recording of hate speech cases and incidents online;
- strengthened cooperation between public authorities, civil society organisations and internet companies, in particular in the area of prevention, reporting, education and awareness raising about tolerance and against hatred online, targeting young people;
- increased public awareness of online hate speech, including through the promotion of positive narratives and online campaigns.

5. Restricted to public authorities to improve their responses to (intersectional) discrimination, racism and xenophobia, in particular based on racial or ethnic origin, religion or colour:

- improved skills of public authorities to effectively investigate, prosecute and

adequately sentence incidents of discrimination and hate crime;

- improved support to victims, better public awareness of rights and increased number of reported incidents;
- improved cooperation and exchange of information among public authorities (in particular municipal and regional administrations), as well as between public authorities and other actors such as civil society organisations and community representatives, to improve responses to discrimination, racism, xenophobia and other forms of intolerance;
- improved knowledge and awareness among public and law enforcement authorities of the impact of discrimination, racism, xenophobia and other forms of intolerance and current trends, and better understanding of the various forms of intolerance and of the legal framework;
- improved system of recording discrimination and hate crimes and collecting data, an improved methodological approach and better inter-institutional cooperation on data collection;
- effective development and implementation of comprehensive frameworks, strategies or plans of action to prevent and combat, racism, xenophobia and other forms of intolerance.

TYPE OF APPLICANTS TARGETED

National Roma Contact Points.

POLICY PRIORITIES

2022

The aim is to support the setting up reinforcing of national consultation processes in the Member States, through National Roma Platforms convened and managed by National Roma Contact Points (NRCPs).

National Roma Platforms aim to promote and facilitate dialogue, mutual learning, cooperation and policy review among all national stakeholders. They are also expected to boost the representation of Roma people in the platform structures, particularly women and youth, including by nominating a Roma representative to ensure a link between National and the European Roma Platforms. National Roma Platforms aim to:

- empower National Roma Contact Points in the process of Roma equality, inclusion and participation;
- mobilise and ensure the continued engagement of all relevant stakeholders (i.e. high level public authorities, Roma and non-Roma communities, civil society organisations, entrepreneurs, trade unions, employers' and child rights organisations, academia, etc.), in particular by providing a forum and encouraging self-mobilisation and cooperation of Roma and pro-Roma civil society organisations;
- strengthen multi-stakeholder accountability, commitment to and ownership and transparency of the process of Roma equality, inclusion and participation;
- boost the commitment to and effective implementation of measures promoting Roma equality, inclusion and participation at the local level, improving equal access of Roma to mainstream services and opportunities and strengthening community building between Roma and non-Roma;
- complement and increase synergies with other EU and/or national initiatives, such as the European Roma Platform and the Roma civil monitor project (ensuring a regular forum for presentation, discussion and debate on its results and recommendations for

policy review);

- address gaps and challenges in the implementation of National Strategies for Roma equality, inclusion and participation specific to the national context, and to report at national and EU level, including data collection and evaluation studies;
- whenever necessary, use the means of the platform to generate immediate responses to challenging situations, such as the COVID-19 pandemic;
- promote participation of Roma women and Roma youth in the design and implementation of the national Roma platform, for example through dedicated internship schemes.

DESCRIPTION OF ACTIVITIES

Activities shall include:

8. mapping of all relevant stakeholders working on Roma equality inclusion and participation and assessing the need and opportunity to include them in the National Roma Platform in order to increase representation and accountability;
9. actions to set up and reinforce national Roma platforms, involving all relevant stakeholders, with a focus on implementing and monitoring National Strategies for Roma equality, inclusion and participation;
10. meetings, working groups, seminars, events at national, regional or local levels, with discussion on topics such as education, employment, health, housing and representation;
11. awareness-raising, dedicated discussion of the results of civil monitoring of the implementation of National Strategies for Roma equality, inclusion and participation;
12. evaluation and review of National Strategies for Roma equality, inclusion and participation; and Roma integration measures, exchange and transfer of practices that proved effective at the local level;
13. transnational exchange between different National Roma Platforms to promote policy learning and transfer of good practices;
14. exchange and participation of the nominated representative of the National Roma Platform in preparatory meetings on the European Roma Platform.

EXPECTED RESULTS

- increased number of national Roma platforms seen as an integral component of coordination and monitoring activities carried out by the national Roma contact points to foster stakeholder dialogue, cooperation and coordination;
- increased capacity of national experts and stakeholders to address issues related to Roma equality, inclusion and participation, including legislative and administrative practises;
- strengthened cooperation and exchange of information between competent national authorities in relation to Roma equality, inclusion and participation;
- increased sustainability of Roma participation in policy processes.

Member State governments, local and regional authorities and their associations, equality bodies, civil society organisations, in particular women's rights organisations.

POLICY PRIORITIES

2022

1. Equal participation and representation of women and men in political and economic decision making

The aim of the priority is to promote equal participation and representation of women and men in political decision making (including the equal representation of women and men and in the 2024 European Parliament elections) and in management and leadership positions in the corporate sector. Indeed, women continue to be under-represented in decision-making positions in political and economic life in many EU Member States³⁷. In line with its Gender Equality Strategy³⁸ and to contribute to achieving the Sustainable Development Goals³⁹, the Commission will support Member States and relevant stakeholders in developing and implementing effective strategies to increase the representation and participation of women in decision making in politics and in the corporate sector.

To address the remaining challenges to achieving equal participation/representation of women and men in political and economic life, co-ordinated action is required in a wide range of areas, with fundamental changes, policies, measures and targeted actions that remove both societal and structural obstacles bearing in mind the need to strengthen women's leadership and participation in the COVID-19 recovery.

Projects should take into account in their objectives and activities women in all their diversity⁴⁰.

2. Tackling gender stereotypes, including with a focus on youth, and in advertising and the media

This priority focuses on actions that raise awareness, at local, national or EU level, to tackle gender stereotypes, including in all spheres of life of young people (particularly schools,

sports, online gaming, social media and other activities), and in advertising and the media. This will include promoting positive messages and portrayals of equality between, and equal chances for, girls and boys, women and men, in order to encourage behavioural change in the society.

This priority will accompany an EU-wide campaign on tackling gender stereotypes, with a particular focus on youth, and other gender equality initiatives that address stereotypes and intersectionalities.

Projects should propose methods and activities that directly involve the target groups, in particular girls and boys, in a creative and innovative way, using positive and progressive messages to promote behaviour change.

DESCRIPTION OF ACTIVITIES

Activities shall include:

1. Equal participation and representation of women and men in political and economic decision making:

- development, implementation, monitoring and evaluation of comprehensive national strategies by Member States' responsible authorities to achieve equal participation/representation of women and men in politics and economic life;
- mutual learning and identification/exchange of good practices between Member States' responsible authorities and/or between relevant stakeholders, such as equality bodies, civil society organisations, in particular women's organisations, and the media; development and/or dissemination of high-quality tools and/or successful strategies aiming to achieve equal participation/representation of women and men in politics and in economic life;
- awareness-raising activities, such as seminars, conferences, campaigns, publications, press activities and social media campaigns, which can include awareness raising about the business benefits of balanced participation of women and men in corporate leadership positions;
- developing/strengthening cooperation/networking between key stakeholders, such as national and/or regional/local authorities and/or their associations, equality bodies, civil society organisations, in particular women's organisations, and increased coalition building.

Activities supporting individual political parties will not be funded by the Commission.

2. Tackling gender stereotypes, including with a focus on youth, and in advertising and the media:

- awareness-raising and empowerment activities;
- capacity building and training for relevant professionals;
- exchange of good practices, mutual learning.

Practical projects that develop and implement specific measures and involve the target group are preferred.

EXPECTED RESULTS

1. Equal participation and representation of women and men in political and economic decision making:

- contribution to the implementation of the Commission's Gender Equality Strategy 2020-2025, in particular its objectives under the 'leading equally throughout society' pillar and to the EU's achievement of Sustainable Development Goal number five on gender equality;
- contribution to the achievement of equal representation of women and men in the European Parliament after the 2024 elections;
- design, development and/or monitoring of national, regional or local policies to promote equal representation of women and men in decision-making positions and processes in politics, public debates and in management and leadership positions in the corporate sector;
- increased capacity of national, regional and local authorities and their associations, civil society organisations, in particular women's organisations, and the media to address the remaining obstacles related to the under-representation of women in all their diversity in politics, public debates and in management and leadership positions in the corporate sector;
- strengthened cooperation, increased networking and exchange of information between Member State governments, local and regional authorities and their associations, equality bodies, civil society organisations, in particular women's organisations, the media, and academics.

2. Tackling gender stereotypes, including with a focus on youth, as well as in advertising and the media:

- tackling gender stereotypes and negative gender roles through awareness raising and training of those who are in daily contact with the target groups, especially young people;
- changed attitudes towards and behaviours concerning the role of women and men, boys and girls, among the general population and particular groups, e.g. relevant professionals, witnesses and bystanders, vulnerable groups, etc.;
- girls and boys, women and men feeling valued and empowered, freed from negative expectations, through identification with progressive gender portrayal and positive messaging.

- dissemination and awareness raising, including social media or press campaigns;

- capacity building and training activities of national, regional and local authorities.

1. increased knowledge about the impact of the COVID-19 pandemic on children, as well as of the public policy responses taken, and lessons learnt for the future;
2. establishment of protocols that ensure the mainstreaming and safeguarding of children's rights and support children in emergency situations in the future;

POLICY PRIORITIES

2021

The report⁴¹ on the first two years of application of Regulation (EU) 2016/679 (General Data Protection Regulation - GDPR) issued on 24 June 2020 highlights that the GDPR is an important component of an area of justice and fundamental rights based on mutual trust and of the human-centric approach to technology in the twin green and digital transitions.

Since the GDPR entered into application on 25 May 2018, the Commission has been working with European Economic Area data protection authorities and stakeholders to assess the evolving context and needs of the various actors involved.

Building on experience gained from the calls for proposals launched in 2017, 2019 and 2020, and in view of implementing the conclusions of the above-mentioned report on the GDPR, actions under this priority should aim to further support activities carried out by national data protection authorities to facilitate the implementation of GDPR obligations by small and medium-sized enterprises, and to raise awareness about the GDPR among the general public.

DESCRIPTION OF ACTIVITIES

Helping national Data Protection Authorities reach out to businesses and the general public by:

- supporting activities carried out by national data protection authorities to facilitate the implementation of GDPR obligations by small and medium-sized enterprises; these activities can in particular include providing practical guidance, templates, and digital tools aimed at small and medium-sized enterprises that can be replicated in other Member States;
- supporting activities carried out by data protection authorities to raise awareness of the GDPR among the general public.

3.8. Call for proposals on European remembrance

BUDGET LINE

Budget line 07 06 02: Promote citizens' engagement and participation in the democratic life of the Union

OBJECTIVE

Supporting projects aimed at commemorating defining events in modern European history, including the causes and consequences of authoritarian and totalitarian regimes, and at raising awareness among European citizens, of their common history, culture, cultural heritage and values, thereby enhancing their understanding of the Union, its origins, purpose, diversity and achievements and of the importance of mutual understanding and tolerance.

Policy initiatives supported: EU Strategy on combating antisemitism, EU anti-racism action plan for 2020-2025, EU Roma strategic framework on equality, inclusion and participation.

TYPE OF APPLICANTS TARGETED

Public local/regional authorities or non-profit organisations, including civil society organisations, survivors' associations, and cultural, youth, educational and research organisations.

POLICY PRIORITIES

2021 and again in 2022

1. Commemoration of and research and education about crimes committed under totalitarian regimes

Reconciliation with the legacy of the crimes committed by totalitarian regimes requires continuous sharing and promoting of this memory as well as research to curb distortion. Education targeting all generations, though in particular younger people, on the importance of safeguarding democracy and fundamental rights should draw on the lessons from crimes committed by totalitarian regimes, in particular the Holocaust.

The programme aims to foster a common culture of remembrance and mutual understanding between people from different countries. This is done notably by supporting projects that reflect on historical turning points and changes in regimes in 20th century Europe and on their continuous importance for today's Europe, and projects that promote the role of Europe's cultural heritage as a pivotal element of cultural diversity, and intercultural dialogue and local heritage linked to European memory.

In this context, priority will be given to Holocaust remembrance, research and education, in light of rising Holocaust denial and distortion, including online. 76 years after the liberation of Auschwitz-Birkenau and other Nazi death camps, public knowledge about the Holocaust is declining. Due to the disappearing number of eyewitnesses, it is essential to find new ways of remembering and educating about the Holocaust to protect society against resurging threats of hatred, discrimination and all forms of antisemitism, as highlighted in the EU Strategy on combating antisemitism and EU anti-racism action plan for 2020-2025.

Projects under this priority can focus on the European dimension of the Holocaust, its root

causes and consequences, as well as on transforming research and testimonies into practical educational tools. Furthermore, projects can aim to tackle the rising challenge of Holocaust denial and distortion and all other forms of antisemitism. In line with the EU Roma strategic framework on equality, inclusion and participation, projects can also focus on commemorating the Roma Holocaust.

2. Resistance, democratic transition and democratic consolidation in the EU

The suppression of basic freedoms such as freedom of speech, assembly, thought, conscience and religion is an integral characteristic of totalitarian regimes, which triggered resistance. Organised opposition and/or ad-hoc resistance from within society have contributed to overcoming totalitarian rule and enabled transition into democracy.

For Member States that experienced in their recent history a transition to democracy, accession to the EU played an important role in supporting and consolidating democratisation. For example, through the system of 'democratic conditionality', membership preparations encouraged political changes and structural reforms, strengthened administrative capacity and improved the protection of minorities.

Projects under this priority should analyse and highlight resistance and/or organised opposition to totalitarian rule leading up to democratic transition, looking into democratic consolidation in the EU. They should focus on how the idea of EU accession influenced democratic standards and practices of the new democracies throughout the accession process, and how it does so today.

While taking stock of the enlargements that took place in the last decades, the projects could also offer the opportunity to discuss future enlargements or other kinds of partnerships with countries of the EU neighbourhood.

DESCRIPTION OF ACTIVITIES

This call supports activities that concern defining moments and developments in recent European history. The aim of these activities is to reflect on European diversity and values to encourage tolerance and respect, mutual understanding, intercultural dialogue and reconciliation. Projects are expected to: (i) include different organization types (local authorities, civil society organisations, research and archival institutes, cultural organisations, memorial and learning sites, etc.), (ii) develop different types of activities (training activities, publications, online tools, (provenance) research, non-formal education, public debates, exhibitions, awareness-rising, collection and digitisation of testimonies, innovative and creative actions, etc.), and; (iii) involve people from different target groups. Projects should have a European dimension and preferably be implemented on a transnational level (involving the creation and operation of transnational partnerships and networks).

EXPECTED RESULTS

- raised awareness of European historical memory and remembrance, including through the development of activities linking remembrance with civic participation and democracy in the broadest sense;
- in the area of projects relating to the Holocaust and other genocides, exchange of views across national boundaries and promotion of a European approach to history, as well as the digitisation of the testimonies of survivors to preserve the memory;
- addition of a European dimension to relevant debates on important historical events

and moments of recent European history;

- contribution to creating lasting changes in participants' attitudes towards the EU and its history, values and culture;
- countering historical distortion, including distortion and denial of the Holocaust;
- identification, safeguarding and making available in particular online, archival material, testimonies and authentic sites for education purposes, commemoration and research.

3.9. Call for proposals on Citizens' engagement and participation

BUDGET LINE

Budget line 07 06 02: Promote citizens engagement and participation in the democratic life of the Union

OBJECTIVE

Promoting citizens' and representative associations' participation in and contribution to the democratic and civic life of the Union by making known and publicly exchanging their views in all areas on Union action

Among the policy initiatives supported: European democracy action plan, EU Citizenship report 2020, Strategy to strengthen the application of the Charter of Fundamental Rights in the EU.

TYPE OF APPLICANTS TARGETED

Non-profit organisations, including civil society organisations, educational, cultural or research institutions. Partners can also be public local/regional authorities.

POLICY PRIORITIES

2022

This call aims to support projects promoted by transnational partnerships and networks directly involving citizens. These projects will gather a diverse range of people from different backgrounds in activities directly linked to EU policies, giving them an opportunity to actively participate in the EU policymaking process in areas related to the programme's objectives.

The call provides an opportunity to broadly cover a variety of policy areas, and to contribute to the promotion of EU values, the rule of law, fundamental rights and democracy. While maintaining a bottom-up approach, there will be a specific focus on:

- **the 2024 European Parliament elections**, which are central to strengthening and nurturing democracy in the EU, with further efforts needed to promote the participation of citizens in the elections. This priority could also promote EU citizenship rights and contribute to the implementation of the European democracy action plan and the EU Citizenship Report 2020;
- exploring **how the COVID-19 crisis has affected the democratic debate and the enjoyment of fundamental rights**;
- **innovative democratic approaches and tools** to help citizens make their voices heard and publicly exchange views on all areas of EU action, notably digital tools ('e-democracy');
- **countering disinformation and other forms of interference in the democratic debate**, empowering citizens to make informed decisions by helping them identify disinformation and promoting media literacy, with journalists' involvement;
- engaging citizens and communities in **discussions and action related to our climate and environment**; there is a growing interest of civil society and associations in discussing climate and green issues and proposing solutions to decision makers.

Projects should support democratic participation, including by stimulating and organising

reflection, debates or other activities related to these priorities. They should also propose practical solutions that can be implemented through cooperation or coordination at European level, support the sharing of good practices, and ensure a practical link with the policy-making process. All projects shall both, at design and implementation stage, allow for equal participation and promote gender-sensitive approaches.

DESCRIPTION OF ACTIVITIES

Projects should gather people from different countries in activities directly linked to EU policies, to provide an opportunity for direct participation in the policymaking process and thus create the conditions for a stronger bottom-up approach and a more inclusive policymaking process, and foster civic and democratic engagement. Projects should include events such as debates, conferences, seminars, campaigns, workshops and cultural activities.

This call for proposals supports activities contributing to fostering democracy, inclusion and democratic participation in the EU by for example: (i) promoting societal engagement through debates, campaigns, awareness-raising, conferences, workshops etc. on the themes relevant to call priorities and providing a link to the European political agenda and policy making process, and; (ii) gathering the opinions of individuals through a bottom-up approach (including use of social networks, webinars etc.) and media literacy; and (iii) promoting exchanges between EU citizens on EU-related topics to foster a better understanding of different perspectives.

EXPECTED RESULTS

- boosting citizens' awareness of rights and values and increasing their degree of engagement in society and with the EU;
- enabling people to deepen their knowledge of the EU institutions and policies, and better understand the EU's achievements and benefits;
- strengthening democratic participation, with a special focus on inclusion of younger and older people, women in all their diversity, mobile EU citizens and people with disabilities;
- stimulating reflection and debates related to the call priorities;
- strengthening the European character of the elections to the European Parliament;
- reaching large numbers of people through events, information material, and (social) media, making best use of new technologies and strengthening media literacy;
- reaching those citizens not active in civic participation in their everyday life;
- making it possible for members of the EU public to communicate their main concerns to the Commission so that these can be addressed through political commitment.

BUDGET LINE

Budget line 07 06 02: Promote citizens engagement and participation in the democratic life of the Union

OBJECTIVE

Promoting exchanges between citizens of different countries, in particular through town twinning and networks of towns, to give them practical experience of the wealth and diversity of the common heritage of the Union and to make them aware that these constitute the foundation for a common future

Policy initiatives supported: European democracy action plan, EU Roma strategic framework on equality, inclusion and participation, Strategy to strengthen the application of the Charter of Fundamental Rights in the EU, EU Citizenship Report 2020.

TYPE OF APPLICANTS TARGETED

Towns/municipalities or their twinning committees or networks; other levels of local/regional authorities; federations/associations of local authorities; non-profit organisations representing local authorities.

POLICY PRIORITIES

2021 and again in 2022

I. Town-Twinning

The programme contributes to promoting intercultural dialogue by bringing people of different nationalities and different languages together and giving them the opportunity to participate in common activities. In this context, Town-Twinning projects will raise awareness of the richness of Europe's cultural and linguistic environment and promote mutual understanding and tolerance, contributing to the development of a respectful, dynamic and multifaceted European identity and the respect of common values, democracy and fundamental rights.

The EU is built on solidarity: solidarity between its citizens, solidarity across borders between its Member States, and solidarity through support actions inside and outside the EU. Solidarity is a shared value that creates cohesion and responds to societal challenges. Town-Twinning projects will contribute to overcoming national perceptions by fostering mutual understanding and by creating fora where common solutions can be discussed in a constructive way. Their aim should be to raise awareness of the importance of reinforcing the European integration process based on solidarity and common values.

At the same time, Town-Twinning projects will give citizens the opportunity to express what kind of Europe they want. Debates supported under the Town-Twinning measure should be based on the EU's specific achievements and on lessons learnt from history. They should also reflect on current trends, and enable participants to challenge euroscepticism and to suggest possible actions that the EU could take to foster a sense of belonging to Europe, to increase understanding of the benefits of the EU and to reinforce

the EU's social and political cohesion.

The COVID-19 pandemic has not only challenged our health and economy, but influenced the ways in which our democracies and civic participation function. The need to prevent the spread of the contagion led to the imposition of strong restrictions on individual and collective freedoms. Civic space under lockdown conditions has been narrowed but at the same time shown a high level of dynamism. Citizens have found creative ways to be useful to their communities, to offer social and cultural tools against isolation, to volunteer for providing support to the weak and vulnerable trying to respond to people's needs.

Town-Twinning projects (as well as Networks of Towns projects) are encouraged to reflect on the impact of the COVID-19 pandemic on the life within and the functioning of local communities as well as on the forms civic participation takes under the COVID-19 crisis.

Indicative budget: EUR 2 745 135 in 2021 and EUR 4 500 000 in 2022.

II. Networks of Towns

Networks of Towns will give towns and municipalities the possibility to deepen and intensify their cooperation and debate, develop sustainable networks and outline their long-term vision for the future of European integration.

The Commission expects Networks of Towns to reflect on a new narrative for Europe, one that is people-oriented, forward-looking and constructive, and that would be more engaging for the younger generation in particular. Projects may be based on the outcome of citizens' consultations and may lead to debates about specific ways to create a more democratic EU, to encourage citizens to re-engage with the EU and help them develop a stronger sense of ownership of the European project.

While maintaining a bottom-up approach, there could be a specific focus on:

2021

- promoting awareness and building knowledge of EU citizenship rights and associated European common values and common democratic standards, ensuring the provision of information to mobile EU citizens, including those in a precarious situation and EU citizens with a migrant background, and their family members, and encouraging the inclusion and democratic participation of mobile EU citizens and under-represented groups;
- promoting awareness, building knowledge and sharing best practice concerning the benefits of diversity as well as effective measures on how to tackle discrimination and racism, at local level;
- promoting awareness and building knowledge of the role of minorities, such as people with a minority racial or ethnic background (for instance Roma), in European society, and their contribution to Europe's cultural development;
- promoting awareness and exchanging best practice concerning the EU Charter on Fundamental Rights and its application at local level.

Indicative budget: EUR 4 200 000.

2022

- identifying ways to further strengthen the European dimension and democratic legitimacy of the EU decision-making process and fostering free, open and healthy democratic governance in an era of low turnout in elections, populism, disinformation and challenges facing civil society, by supporting citizens' active

- involvement in European political life and the exercise of their electoral rights;
- supporting the integrity of free and fair elections in Europe, preserving the EU's democratic institutions and citizens' participation in them; coordination within and among relevant networks could lead in particular to the establishment of common working methods, capacity building to detect and address threats to elections, best practices and guidelines.

Indicative budget: EUR 6 500 000.

DESCRIPTION OF ACTIVITIES

Activities related to Town-Twinning and Networks of Towns may include workshops, seminars, conferences, training activities, expert meetings, webinars, awareness-raising activities, data gathering and consultation, development, exchanges and dissemination of good practices amongst public authorities and civil society organisations, development of communication tools and the use of social media.

I. Town-Twinning

This measure aims to support projects that bring together a wide range of people from twinned towns around topics related to the programme's objectives. By mobilising members of the public at the local and EU levels to debate specific issues on the European political agenda, this measure will seek to promote mutual understanding, inclusion and cultural diversity and develop opportunities for civic engagement at the EU level.

II. Networks of Towns

Under this measure, municipalities or regions and associations working together in a long-term perspective are invited to develop networks of towns to make their cooperation more sustainable and to exchange good practice.

Networks of Towns are expected to integrate a range of activities around subjects of common interest related to the programme's objectives, to involve community members active in the subject area and to aim for sustainability.

EXPECTED RESULTS

I. Town-Twinning:

- increase in and encouragement of mutual understanding and friendship between citizens at a local level;
- helping citizens from local communities to experience and recognise the added value that the EU provides through a grassroots approach;
- an increased sense of belonging to the EU.

II. Networks of towns

- an opportunity for towns and municipalities to develop larger-scale projects with the aim of increasing their projects' impact and sustainability;
- possibility for beneficiaries to develop more thematic and policy-related projects;
- lasting links with partner organisations;
- raised awareness of the benefits of diversity and the tackling of discrimination and racism;
- increase in and encouragement of mutual understanding and acceptance of European minorities, such as Roma;
- raised awareness on the EU Charter on Fundamental Rights and its application, and

- promotion of a culture of fundamental rights;
- better information on the rights conferred by EU citizenship and their improved implementation in Member States;
- raised awareness and better provision of information to mobile EU citizens and their family members on their EU citizenship rights.

- activities must take place in one of the eligible countries participating to the project;
- the maximum duration of the project is 12 months.

To be eligible, grant applications for Networks of Towns must comply with all of the following criteria:

- applicant and partners are either a public body or a non-profit organisation with legal personality, established in an eligible country participating in the programme;
- applicants are towns/municipalities and/or other levels of local authorities, their twinning committees or other non-profit organisations representing local authorities;
- the project must involve municipalities from at least five eligible countries of which at least three are EU Member States;
- activities must take place in at least two different eligible programme countries;
- the maximum duration of the project is 24 months.

MAXIMUM POSSIBLE RATE OF CO-FINANCING OF THE ELIGIBLE COSTS

Lump sum funding - for Town-Twinning the maximum grant amount is EUR 30 000.

3.11. Call for proposals to prevent and combat gender-based violence and violence against children

BUDGET LINE

Budget line 07 06 03: Daphne

OBJECTIVES

To fight violence, including gender-based violence:

- 1. preventing and combating at all levels all forms of gender-based violence against women and girls and domestic violence, including by promoting the standards laid down in the Council of Europe Convention on preventing and combating violence against women and domestic violence;*
- 2. preventing and combating all forms of violence against children, young people and other groups at risk, such as LGBTQI persons and persons with disabilities;*
- 3. supporting and protecting all direct and indirect victims of the forms of violence referred to in points (1) and (2), such as the victims of domestic violence perpetrated within the family or within intimate relationships, including children orphaned as a result of domestic crimes, and supporting and ensuring the same level of protection throughout the Union for victims of gender-based violence.*

Policy initiatives supported: Gender Equality Strategy, EU strategy on the rights of the child, EU Strategy on victims' rights.

TYPE OF APPLICANTS TARGETED

Member States' public authorities, support services, civil society organisations.

POLICY PRIORITIES

2021

1. Early detection, prevention and protection of and/or support to women, children, and young people victims or potential victims of violence, with specific attention paid to situations emerging from the COVID-19 pandemic

Helplines and support services reported that violence against children, women and LGBTQI people has been on the rise during the COVID-19 pandemic. Staying at home because of the lockdown has affected in particular women and children living with a perpetrator, those negatively affected by prolonged judicial procedures, women and children with disabilities or in migration, as well as children in alternative care. Increased internet usage during lockdown has also led to a rise in incidents of online violence.

The aim of this priority is to address (potential) victims' needs within existing support mechanisms, as well as to fund programmes that provide early detection, prevention and adequate support. This involves the strengthening of gender-specific and child-centred responses to violence, through capacity-building and strengthened multi-disciplinary cooperation and coordination among relevant actors, such as law enforcement and judicial professionals, victim support services, IT platforms and regulatory bodies.

This call aims to contribute to the implementation of:

- the provisions of the Council of Europe Convention on preventing and combating violence against women and domestic violence, particularly Chapters IV and V related to support and protection measures;
- Directive 2012/29/EU establishing minimum standards on the rights, support and protection of victims of crime.

Indicative funding available for this priority: EUR 13 475 300.

2. Preventing gender-based violence by addressing masculinities and the engagement of men and boys

The objective is to end men's violence against women and girls, including honour-related violence and oppression, while acknowledging that men and boys have an important role to play in violence prevention. Actions can focus on different areas such as: i) early intervention to address adverse childhood experiences and break the cycle of violence; ii) a universal (primary) prevention approach, for example, by working with young people; and iii) a targeted prevention approach through perpetrator treatment programmes to prevent recidivism.

The focus is on: (i) addressing violent norms of masculinities; (ii) supporting the development of non-violent relationships by engaging men and boys as allies; (iii) treatment of perpetrators through prevention programmes; and (iv) ensuring that men and boys become change agents benefitting from non-violence and gender equality. The involvement of men and boys in the prevention of gender-based violence against women can take on many forms, including by using role models, agents of change and advocates for equality between women and men and mutual respect.

The focus should be on engaging with men to challenge other men's behaviour to transform unequal power relations between women and men and to tackle violence against women. Women's and girls' safety and rights must be central in all actions.

Indicative funding available for this priority: EUR 4 224 700.

2022

1. Large-scale and long-term transnational actions to tackle gender-based violence

In line with the Gender Equality Strategy, this priority aims to support the development of large-scale, integrated actions to combat gender-based violence, and achieve long-term and structural changes with a wide geographical coverage.

The objective is to achieve balanced coverage of actions across different areas of intervention in line with the priorities of the Gender Equality Strategy. To do this, a number of transnational proposals must be selected, each focusing on different priorities, such as:

- **domestic violence:** increasing awareness of and access to support services for (potential) victims, strengthening gender-specific responses to domestic violence (including for witnesses of domestic violence), through capacity-building and multi-disciplinary strengthened cooperation and coordination among relevant actors;
- **harmful practices:** tackling female genital mutilation and forced sterilisation, early and forced marriage, 'honour-related violence' and other harmful practices against women and girls;
- **online violence targeting women and girls:** tackling gender-based cyber violence, such as incitement to violence, online stalking, non-consensual image sharing,

extortion with the use of sexual imagery ('sextortion'), sexual or gendered online harassment and bullying, grooming, etc;

- **violence and harassment in the world of work:** tackling physical and psychological offline and online violence or harassment in work contexts by, in particular, preventing such unwanted behaviours, encouraging the development and implementation of remedies and victim support mechanisms, and the development of relevant tools, guidance, education and training;
- **gender stereotypes:** preventing gender-based violence by tackling prejudices and gender stereotypes, in particular those related to masculinities, norms, attitudes and behaviours that encourage, condone or minimise violence, as well as by providing women and men, girls and boys, in all their diversity, with the tools to call out and stand up to violence through empowerment and bystander intervention programmes.

In order to ensure on-the-ground interventions and wide coverage, the partnership should ensure collaboration with actors in different sectors and organisations guaranteeing a multiplier effect. Proposals will have to develop a long-term programme of intervention in view of achieving changes in attitudes and behaviour, guaranteeing impact and reaching out to a large number of participants in different geographical areas of the EU and covered by the programme. They must include an effective and detailed monitoring and evaluation system, which will enable partners to evaluate the impact of their intervention.

Indicative funding available for this priority: EUR 10 000 000.

2. Combating and preventing violence linked to harmful practices

This entails combating, raising awareness and preventing violence linked to harmful practices such as female genital mutilation, forced or early-age marriage or forced sexual relationships, so-called 'honour crimes' committed against women, young people and children. It includes the strengthening of public services, prevention and support measures, capacity building of professionals and victim-centred access to justice.

Actions should focus on changing attitudes in impacted communities, including through dialogue, mutual learning and exchange of good practice. Projects must incorporate direct community participation, including targeted awareness raising, education as well as promotion of dialogue within impacted communities. Actions must take a child-centred approach and/or a gender-sensitive approach depending on the target group.

Indicative funding available for this priority: EUR 6 000 000.

3. Primary prevention of gender-based violence

The focus of this priority is on primary prevention, in particular changing social norms and behaviour, in order to end tolerance of all forms of gender-based violence. This includes specific and practical awareness-raising, education and training activities to tackle prejudices and gender stereotypes and norms that encourage, condone or minimise violence, as well as to provide women and men with the tools to call out and stand up to violence through empowerment and bystander intervention programmes. Any form of gender-based violence can be covered under this priority. Proposals must explain which social norms and behaviours they aim to address and justify how activities encouraging or discouraging these attitudes and behaviours will directly contribute to the prevention of gender-based violence.

Indicative funding available for this priority: EUR 7 000 000.

4. Supporting and improving national data collection on violence against children

Collection of data on violence against children is very fragmented. There are gaps at all levels, making the response to violence more difficult. This priority aims to foster efforts towards more sustainable and comprehensive data collection at local and/or national level.

Indicative funding available for this priority: EUR 2 000 000.

5. Strengthening responses that prevent and support child victims of violence by reinforcing child protection systems at national and local level

An effective response to violence (in all its forms) is only possible when it is well coordinated among all relevant stakeholders. Too often, services work in silos, with little referral between relevant services, or lack of follow-up to cases in the long term. Prevention activities are separated from protection and support to victims. The objective of this priority is to contribute to systemic changes at national level, and ultimately create integrated child protection systems, for a more effective prevention and protection of victims.

Indicative funding available for this priority: EUR 2 000 000.

DESCRIPTION OF ACTIVITIES

Activities shall include:

- awareness-raising and empowerment activities;
- capacity-building and training for professionals;
- design and implementation of protocols, development of working methods and tools, coordination platform and groups;
- design of services and measures improving access to victim support services;
- exchange of good practices, mutual learning;
- creation and implementation of data collection strategies and systems.

Practical projects developing and implementing specific measures are preferred. While research is not excluded, if research activities are to be part of the project, they must be strictly linked to the project as a whole.

It is strongly encouraged to involve a public authority to actively participate in the projects. This requirement will be assessed under award criterion (b) quality of the proposed action.

EXPECTED RESULTS

2021

1. Early detection, prevention and protection of and/or support to women, children and women victims or potential victims of violence, with specific attention paid to situations emerging from the COVID-19 pandemic:

- increased access to support services, such as, helplines, shelters and counselling services;
- changed attitudes and behaviours concerning domestic violence and online violence

(including lower tolerance of violent behaviour and decreased victim-blaming) among the general population and particular groups, e.g. relevant professionals, witnesses and bystanders, vulnerable groups, etc.;

- prevention of violence through education about gender equality and healthy relationships, as well as the empowerment of women;
- improved detection and reporting of (early signs of) violence;
- increased capacity of stakeholders and relevant professionals to address issues related to domestic violence, including through strengthened multi-agency cooperation;
- victims' safety is guaranteed and further violence prevented;
- cases of violence across borders are properly addressed, through the application of Directive 2011/99/EU on the European protection order;
- increased reporting of violence to the police and other services, with appropriate mechanisms in place to facilitate this;
- increased likelihood of bystander intervention;
- increased prevention of situations of violence against children;
- strengthened protection and support to child victims of violence;
- reinforced capacity of professionals to prevent, detect and respond to violence against children;
- strengthened child protection systems; increased cooperation among relevant services;
- better response to the COVID-19 pandemic with respect to the needs of children.

2. Preventing gender-based violence by engaging men and boys:

- increased engagement of men and boys in tackling gender-based violence against women and supporting the development of non-violent relationships;
- prevention of violence before it happens through education about gender equality and healthy relationships;
- increased likelihood of bystander intervention;
- increased capacity of stakeholders and relevant professionals to address issues related to gender-based violence and engagement of men and boys, including through strengthened multi-agency cooperation;

Legal basis: Article 12(3) of [Regulation (EU) of the European Parliament and of the Council establishing the Citizens, Equality, Rights and Values programme] and Article 195(d) of the Financial Regulation.

POLICY PRIORITIES

2021 and again in 2022

The focus is on promoting equal treatment of all people and eliminating discrimination on grounds of racial or ethnic origin or sex.

In accordance with EU acts on equal treatment, Member States set up independent bodies for the promotion of equal treatment, commonly known as 'equality bodies', in order to combat discrimination based on race and ethnic origin as well as gender.

Equality bodies play a key role in promoting equality and ensuring effective application of equal treatment legislation by providing in particular independent assistance to victims of discrimination, conducting independent surveys on discrimination, publishing independent reports and making recommendations on any issue relating to discrimination in their country. It is essential that the work of equality bodies is coordinated at EU level.

EQUINET, the European Network of Equality Bodies (registered in Belgium), was created in 2007. Its members are the national bodies for the promotion of equal treatment created under: (i) Article 13 of the Racial Equality Directive 2000/43/EC, (ii) Article 12 of Directive 2004/113/EC on equal treatment between men and women in goods and services, (iii) Article 20 of Directive 2006/54/EC on equal treatment between men and women in employment, or (iv) Article 11 of Directive 2010/41/EU on equal treatment between men and women in self-employment.

EQUINET is the only entity that ensures coordination of activities between equality bodies. This coordination is key for the proper implementation of EU anti-discrimination law in Member States.

The Commission will invite EQUINET in writing to submit its proposal presenting its annual policy priorities.

DESCRIPTION OF ACTIVITIES

This grant aims to support activities implemented in 2022 and 2023 by the European Network of the Equality Bodies, specifically for sharing experiences and good practices, trainings, awareness raising and studies.

EXPECTED RESULTS

- increased capacity of experts from national equality bodies to address issues related to non-discrimination and the implementation of EU legislation in the field;
- strengthened cooperation and exchange of information between equality bodies;
- improved knowledge of the legislation and administrative practices related to non-discrimination.
