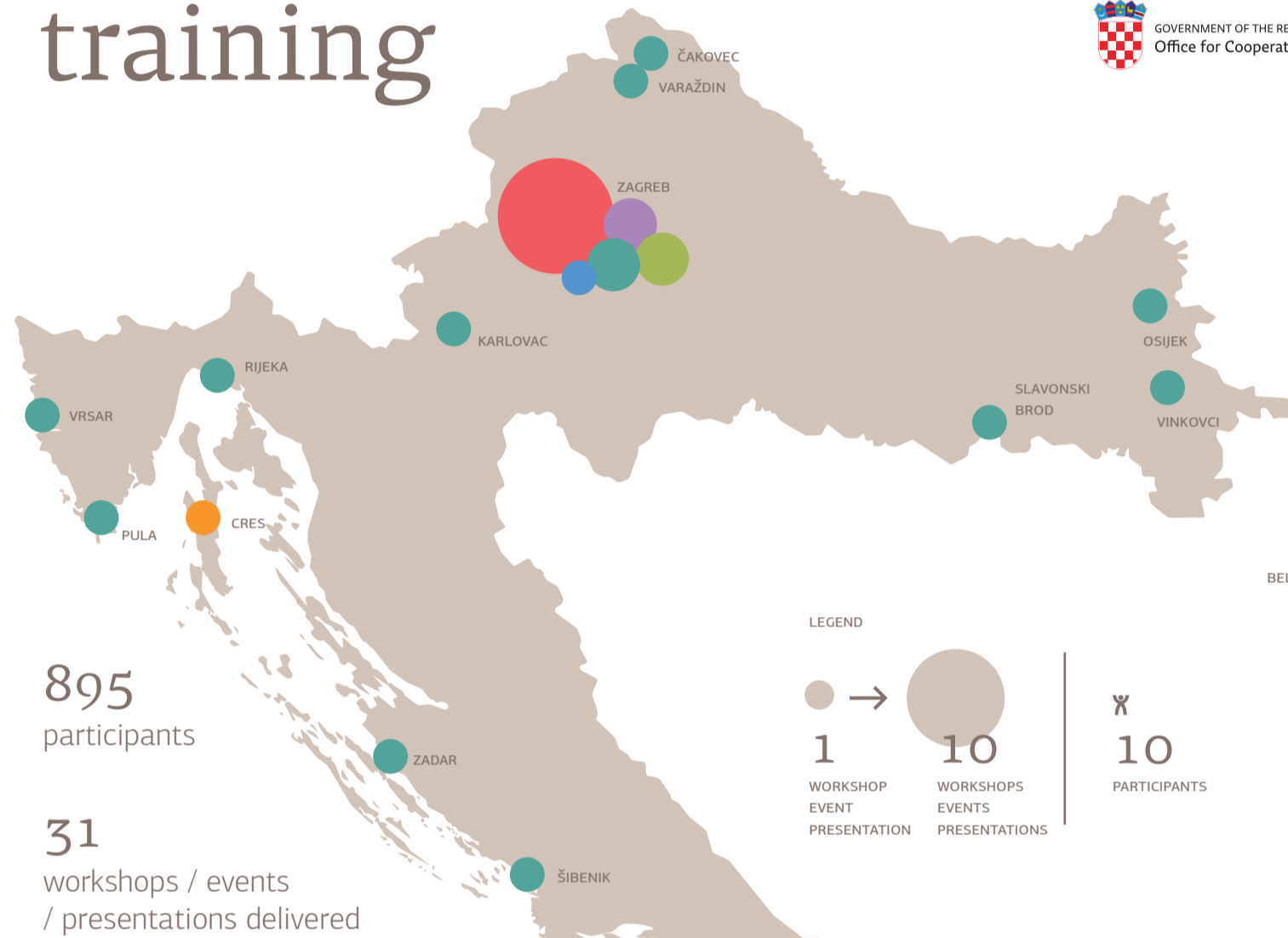
Method of reply to inquiry



Type of inquiry

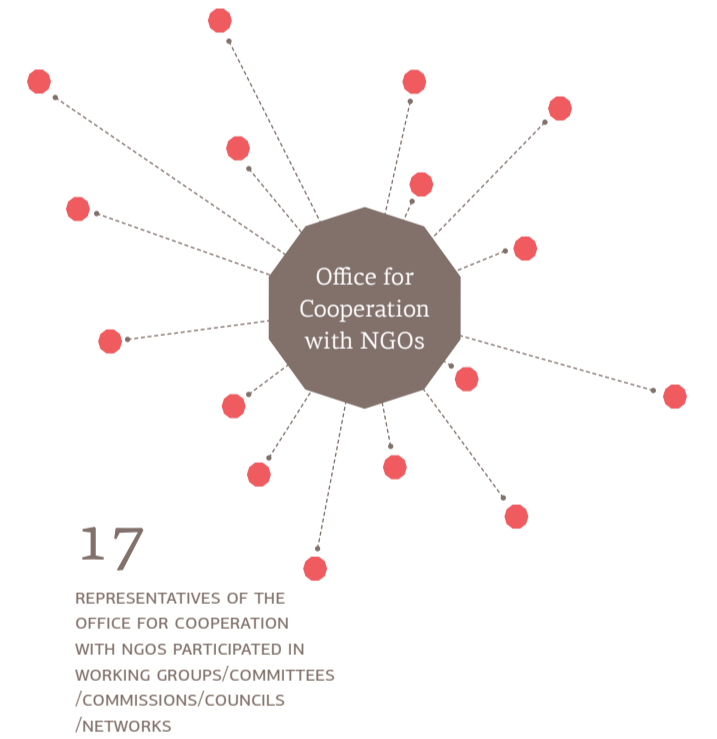

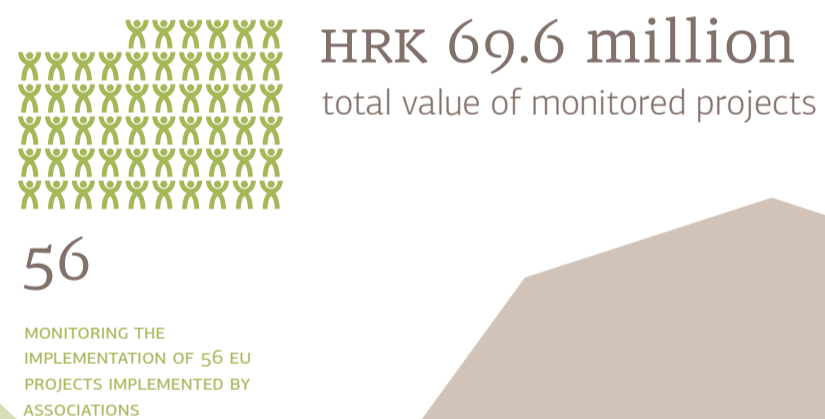

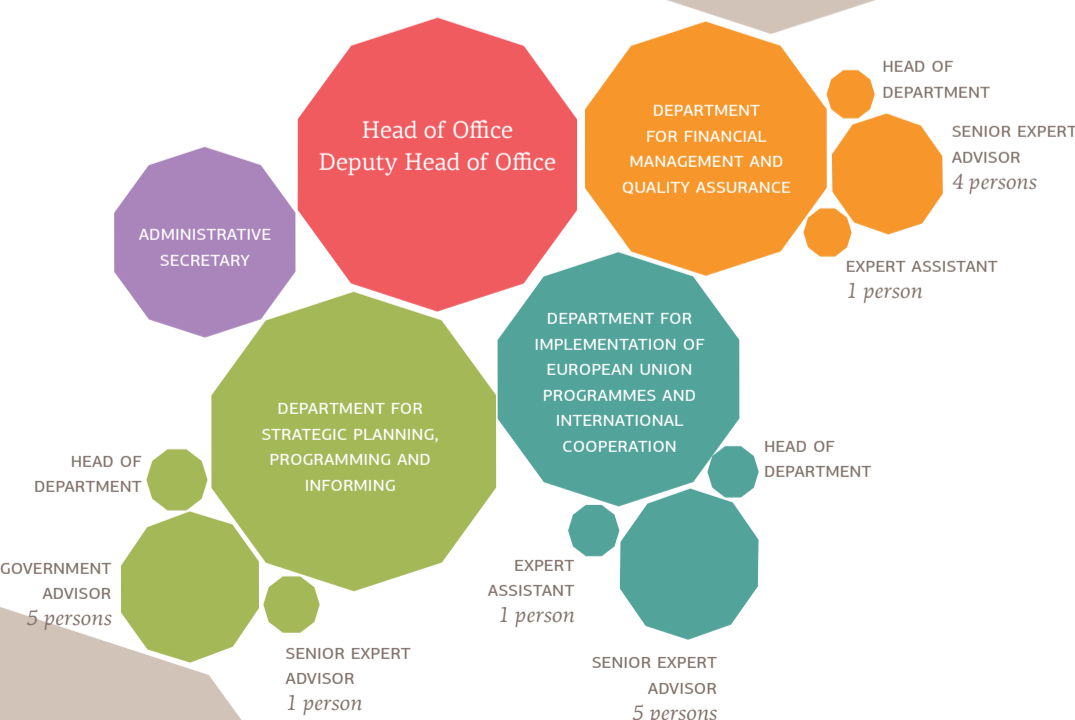
